is Assistant Professor of Classics at Dartmouth College. He has published articles and book chapters on Ennius, Vergil, Manilius, Phaedrus, and the *Prometheus Bound*. At present, he is completing a book about the intersection of scientific thinking and the sublime in imperial Latin literature that focuses on Manilius, Seneca, Lucan, and the anonymous *Aetna*.

is an instructor in the Department of Languages, Literatures and Cultures at the University of South Carolina, where he teaches courses in Latin and classical mythology.
