Notes on Contributors

Victor D. Boantz

is a professor in the Program for the History of Science, Technology, and Medicine at the University of Minnesota. He is working on the history of the early modern physical sciences, especially matter theory, chemistry, and experimental science.

Margaret Carlyle

is an Assistant Professor at the University of British Columbia Okanagan. She is an historian of science, medicine, and technology with specialization in early modern France in both European and global contexts. Her current research focuses on women's role in the formation of scientific knowledge—as experimentalists, artisans, and translators. She engages with archival and museum sources, including manuscripts, printed texts, drawings, engravings, and objects. Themes of interest include: the visual culture of science; medical techniques and technologies; gender and science.

Rob Iliffe

is Professor of History of Science at the University of Oxford. He has written widely on the history of early modern science, and is the author of *A Very Short Introduction to Newton* (Oxford University Press, 2007) and *Priest of Nature: the Religious Worlds of Isaac Newton* (Oxford University Press, 2017). He is the co-director of the Newton Project, and the director of the Newton Mint Papers Project.

Jasmine Kilburn-Toppin

joined Cardiff University as Lecturer in Early Modern History in January 2020, with particular research interests in artisanal cultures, urban space and architecture, and networks of craft and 'scientific' knowledge in Early Modern England. Her monograph, *Crafting identities: artisan culture in London, c.1550–1640* (Manchester University Press, forthcoming 2021), argues that the livery halls of artisanal guilds became multifunctional sites for technical innovation, civic memorialisation, and social and political exchange.

Trevor H. Levere

is a historian of science who has written mainly about the history of chemistry, and also about science and the Canadian Arctic; science and Romanticism; scientific instruments; and the history of science in Canada. His books include *Affinity and Matter* (Oxford University Press, 1971), *Poetry Realized in*

Nature (Cambridge University Press, 1981), *Science and the Canadian Arctic* (Cambridge University Press, 1993), and *Transforming Matter: a History of Chemistry from Alchemy to the Buckyball* (Johns Hopkins University Press, 2001). He is currently exploring the interplay between concepts, apparatus and experimentation in the history of chemistry. He is University Professor Emeritus at the University of Toronto, where he was first appointed in 1968.

Alice Marples

is a historian of science and medicine in Britain and its colonial networks c.1650–1850, currently working on the Newton Project at the University of Oxford. Her work focuses on the collection and management of manuscript, material, and human resources across scientific institutions and international networks. Her first book, *The Transactioneer: Hans Sloane and the Rise of Public Natural History in Eighteenth-Century Britain*, is forthcoming with Johns Hopkins University Press.

Gordon McOuat

teaches in the History of Science and Technology Program at the University of King's College/Dalhousie University. His work focuses on the history and philosophy of logic, classification, and the origins of “natural kinds”, and, globally, the cross boundary circulations of knowledge.

Larry Stewart

is Professor Emeritus at the University of Saskatchewan and visiting scholar at the University of King's College, Halifax, Canada. He has published numerous works on the public response to science in the early-modern world and is currently writing a study of the scientific life of the itinerant lecturer James Dinwiddie.

Marie Thébaud-Sorger

is Researcher (with tenure) at the French National Center for Scientific Research (CNRS) based at the Centre Alexandre-Koyré, Paris, and associated to the Maison française in Oxford where she ran a History of Science programme (2017–2020) and is co-leading the Interdisciplinary Network, *Writing technologies* at the Oxford Research Centre in the Humanities (TORCH). She published extensively on the lighter-than-air machines in French and European societies in her first monograph, “Ballooning in the Age of Enlightenment” (*L'aérostation au temps des Lumières* (Presses Universitaires de Rennes, 2009), the culture of flight, on the public sphere of technology, and how inventive practices in Eighteenth Century Europe shaped communities around technical improve-

ments, especially focusing on the management of fires and “stale/noxious/foul air”. Recent work includes “Changing Scale to Master Nature” (2020), and “Capturing the Invisible: Heat Steam and Gases at the Crossroads of Inventive Practices (2017).

Simon Werrett

is Professor of the History of Science in the Department of Science and Technology Studies at University College London. Werrett’s work explores exchanges between practical arts and sciences in the sixteenth to nineteenth centuries. His first monograph *Fireworks: Pyrotechnic Arts and Sciences in European History* (University of Chicago Press, 2010) examines fireworks and natural philosophy in Britain, France and Russia c.1500–1800. His second book *Thrifty Science: Making the Most of Materials in the History of Experiment* (University of Chicago Press, 2019) explores the history of experimenting in the home. He has also co-edited, with Lissa Roberts, *Compound Histories: Materials, Production, and Governance, 1760–1840* (Brill, 2017).
