is Professor at the Department of Historical Studies II (Modern History) at the Heinrich Heine University of Düsseldorf. She was a research fellow at the German Historical Institute Washington in 2011–12 and at the excellence cluster LOEWE-Schwerpunkt: 'Außergerichtliche und gerichtliche Konfliktlösung' at the Goethe-Universität/Max Planck Institute, Frankfurt am Main, 2013-14, and a fellow at the Historische Kolleg München in 2015–16 and 2020. #### Bert De Munck

is full Professor in History at the University of Antwerp, teaching 'Early Modern History', 'Theory of Historical Knowledge' and 'History of Science and Society'. He is a member of the Centre for Urban History, Antwerp, and Director of the interdisciplinary Urban Studies Institute and the international Scientific Research Community (WOG) 'Urban Agency'. #### David Garrioch

is Emeritus Professor of History at Monash University, Melbourne. He has worked on early modern and particularly eighteenth-century urban social and religious history and the history of policing, of friendship and of women's letters. He is currently researching urban fire in early modern Europe, and the mobility of artisans between Paris and other European cities in the eighteenth century. His publications include *The Making of Revolutionary Paris* (Berkeley: University of California Press, 2002); *The Huguenots of Paris and the Coming of Religious Freedom* (Cambridge: Cambridge University Press, 2014); and 'Sounds of the City: The Soundscape of European Towns, Seventeenth to Nineteenth Century' (*Urban History* 30, 2003). He has recently published 'Towards a Fire History of European Cities, 1500–1850' (*Urban History* 46, 2019).

#### Sander Karst

was trained as an art historian at Utrecht University, where he received his PhD in 2021. His dissertation, which should be published in English in the near future, discusses the participation of artists from the Low Countries in the emergence of a national school of painting in England during the decades around 1700. He is currently teaching at the Department of Art History of the University of Amsterdam.

#### Simon Macdonald

is an Associate Lecturer in Modern European History at University College London. His research focuses on Franco–British connections and conflicts across the eighteenth century, and especially during the French Revolution. His current book project, *Enemies of the Republic: Policing the British in Revolutionary Paris*, historicises the idea of a foreign community and of bordercrossing lives during a critical point in the formation of both the British and French nation-states. Her research focuses on the textile and glass industries, on artisan migration, and on the temporal dimension of working life. Her publications include *Les rythmes du labeur: Enquête sur le temps de travail en Europe occidentale, XIVe–XIXe siècle*, co-written with Didier Terrier (Paris: La Dispute, 2020); and *Les chemins de verre: Les migrations des verriers d'Altare et de Venise, XVIe–XIXe siècles* (Rennes: PUR, 2009).

#### Matthew Martin

is a Lecturer in Art History and Curatorship at the University of Melbourne. From 2006 to 2019 he was a curator in the Department of International Decorative Arts in the National Gallery of Victoria, Melbourne. His research interests include the cultural aesthetics of porcelain in eighteenth-century Europe, and the impact of confessional identity in eighteenth-century European artists' networks. Recent publications include 'Porcelain and Catholic Enlightenment: The Zwettler Tafelaufsatz' (*Eighteenth-Century Life* 45/3, 2021); and 'Porcelain and Power: The Meaning of Porcelain in *ancien régime* France' (in *The Versailles Effect: Objects, Lives and Afterlives of the Domaine*, edited by Mark Ledbury and Robert Wellington. #### José Antolín Nieto Sánchez

is Professor of Early Modern History at the Autonomous University of Madrid. In 1996 he co-edited, with Victoria López, *El Trabajo en la Encrucijada: Artesanos urbanos en la Europa de la Edad Moderna* (Madrid: Grupo Taller de Historia Social, 1996), bringing together several European specialists in craft work in the early modern period. Since then, his research has focused on the world of pre-industrial crafts, with special attention paid to guild organisation, the reproduction of crafts, labour conflict, street vending and rural industry. The focus began as Madrid, but in recent years he has taken a comparative perspective that includes Castile and the American viceroyalties. In recent years he has been developing several databases, at the national and Latin American level, on artisan apprenticeship and access to master's degrees. In 2007 he was awarded the Villa de Madrid prize for municipal research for his book *Artesanos y mercaderes: una historia social y económica de Madrid, 1450–1850* (Madrid: Editorial Fundamentos, 2006).

#### Maarten Prak

is Professor Emeritus of Economic and Social History at Utrecht University. He has published extensively about artisans, including two edited volumes published by Cambridge University Press: *Guilds, Innovation and the European Economy*, 1400–1800 (with S. R. Epstein, 2008) and *Apprenticeship in Early Modern Europe* (with Patrick Wallis, 2020); and another published by Brill: *Technology, Skills and the Pre-Modern Economy in the East and the West* (with Jan Luiten van Zanden, 2013).

#### Nicoletta Rolla

is Associate Researcher at the laboratory 'Analyse comparée des pouvoirs', Gustave Eiffel University (formerly Marne-la-Vallée) in Paris, and Associate Researcher at the Laboratory of Alpine History at the University of Italian Switzerland in Mendrisio. Her PhD was from the University of Pisa in cotutelle with the École des Hautes Études en Sciences Sociales in Paris. She has received funding from the University of Milan, the Luigi Einaudi Foundation of Turin, and the Gerda Henkel Foundation, and was a Marie Skłodowska-Curie fellow at the Centre des Recherches Historiques de l'École des Hautes Études en Sciences Sociales (2013-16). Her research focuses on the economic and social history of pre-industrial Europe, particularly migration and the history of labour in the construction sector. Recent publications include 'Espaces sous tensions: Chantiers du bâtiment et relations de travail à Turin au XVIIIe siècle' (in *Construire! Entre Antiquité et Époque contemporaine*, edited by Gilles Bienvenu, Hélène Rousteau Chambon and Martial Monteil. Paris: Éditions Picard, 2019); 'Temporalités à l'œuvre dans les chantiers du bâtiment: Réseaux professionnels et circulations des entrepreneurs en Piémont au XVIIIe siècle', with Pascal Cristofoli (*Temporalités: Revue de Sciences sociales et humaines* 27, 2018); and 'Spatiality and Mobility of Labour in Pre-Unification Italy (Eighteenth and Nineteenth Centuries)', with Laura Di Fiore (in Micro-Spatial Histories of Global Labour, edited by Christian G. #### Beatrice Zucca Micheletto

is research fellow at the MoHu Centre, University of Padua. She has been a Marie Skłodowska-Curie fellow at the University of Cambridge. She is research affiliate at The Cambridge Group for the History of Population and Social Structure (University of Cambridge) and at the Groupe de Recherche d'Histoire (University of Rouen-Normandy), co-vice-chair and co-leader of the working group 'Labour, belongings and economy' in the COST Action *Women on the Move*, and a member of the working group 'Labour and family economy' in the European Labour History Network. Her research focuses on women's and gender history, history of the family, labour history, and history of migration in early modern Italy and France. Her publications include *Travail et propriété des femmes en temps de crise (Turin, XVIIIe siècle)* (Rouen and Le Havre: PURH, 2104); 'The Domestic Space as a Space of Paid and Unpaid Work' (in *The Routledge History of the Domestic Sphere in Europe (16th to 19th Century)*, edited by J.
